# Terms and Conditions — Pistang Pilipino 2025 Travel Raffle

## 1. Organiser

This raffle is organised by Philippine Culture and Migrant Services Trust (PCMST) in partnership with Advice4Life, in support of Pistang Pilipino sa Christchurch 2025.

### 2. Eligibility

- Open to all persons 18 years and over.
- Tickets cost NZD \$10 each and are non-refundable.
- Trustees, sponsors, organisers, and their immediate families may not be eligible to enter, at the discretion of the organisers.
- Purchasing a ticket constitutes acceptance of these Terms and Conditions.

#### 3. Tickets

- Each valid ticket purchased represents **one entry** into the draw.
- Tickets must be purchased only from authorized raffle sellers.
- Lost or damaged tickets will not be replaced.

#### 4. Prizes

- 1st Prize: One (1) round trip ticket to the Philippines.
- 2nd Prize: One (1) round trip ticket to Australia.
- 3rd Prize: One (1) round trip ticket for domestic New Zealand travel.
