26th October 2025

800AM - Check-in/Warmups 830AM - Mixed Doubles (All Events and Categories) 200PM – Semi-Finals and Finals (All Events and Categories) Awarding will follow after the Final games.

Rules and Guidelines

- 1. Any player entered must be a member of, and in good standing with a Club affiliated to the Federation.
- 2. The rules of play shall be those of the Badminton World Federation.
- 3. The BWF scoring system is to be used.
- 4. Service rule. This event will be played using the Alternative Service Law 9.1.6. a) the whole shuttle shall be below the server's waist at the instant of being hit by the server's racket. The waist shall be considered to be an imaginary line round the body, level with the lowest part of the server's bottom rib; b) the shaft and the racket head of the server's racket at the instant of hitting the shuttle shall be pointing in a downward direction.
- 5. All questions as to the rules shall be resolved by an appointed tournament official.
- 6. RSL Tournament with Speed 78 feather shuttles will be used.
- 7. There will be one plate event in each event at this tournament if numbers are sufficient. Plate entry is automatic for the losers of their first match. Players wishing to withdraw must advise the Tournament Controller immediately after their first match loss. If a player defaults, withdraws or retires (does not compete) their first match, they are not eligible for the plate.
- 8. Categories with only 2 entries (ex. Vets WD) will play best of 2 games of scoring best of 3 sets 21 points, no setting of each game.
- 9. The tournament director and/or Referee reserve the right to cancel any event in which fewer than 4 entries are received, or its time does not permit a full competition to be played. The tournament director and/or Referee reserve the right to default any player who is not available to play at the scheduled time.
- 10. The tournament will be seeded using the most recent Badminton Player Ranking available as at the close of entries.
- 11. Elimination round through to Quarter Finals will be scoring best of 3 sets of 21, no setting.
- 12. Round Robin will be scoring best of 3 sets of 21, **no setting.**
- 13. Plate Round to all levels and categories will be **scoring 1 to 31 points.**
- 14. Semi Finals and Finals will be scoring best of 3 sets of 21 points, with setting.
- 15. Warm up time given per match is 2 minutes.

- 16. Players are called 2 minutes prior to their schedules and need to assemble at the match control area left side the match control desk before heading to each assigned court.
- 17. Default time is 5 minutes after players name have been called by the match control to avoid default and penalty as per General Rules under sec. Defaulting Games.
- 18. Umpire your own games unless umpire is requested. (Elimination to Quarter Finals)
- 19. Technical Officials/Certified Umpires will umpire for the Semi-Finals and Finals event. Please note BWF scoring and rules will be implemented.

PLAYER REQUIREMENTS

- 20. Maximum of 3 Badminton events per player/participant across each category.
- 21. Players must obtain permission to leave the hall.
- 22. Players will be defaulted if they are not on court ready to play within two minutes of being called.
- 23. Players are advised to wear team uniform.
- 24. All players must act as umpires or line judges when requested. Failure to do so may result in the player being defaulted.
- 25. Players compete at their own risk. No responsibility from the Pistang Pinoy in Christchurch Organizer will be accepted for any injury received during the tournament.
- 26. Following one warning of misconduct, the Referee/tournament director shall have the authority to disqualify a player from further play if there is a repeat of misconduct.
- 27. Players are discouraged to play multiple sports. If playing other than badminton, you must advise the person in charge/committee and must be in the badminton hall two (2) hours before your schedule. Otherwise, default decision will apply.
- 28. No eating in the court side. There are lots of spaces upstairs to accommodate players who would like to take a break and eat. Please bear in mind that this is a rule imposed by the Badminton Canterbury Hall.
- 29. Once draw has been published all coordinators will be informed and they need to double check their entries and advise the badminton committee immediately for missing names or any incorrect entry.
- 30. Schedules of game will be published 5 days before the event and can be checked through the Badminton New Zealand Tournament Software website.
- 31. Please return the used and unused shuttles to the lovely lady in the shuttlecock control desk
- 32. Allocation of Points as per below:

Ranking Points shall be distributed as follows:

Match won 2-0 is 3 points.

Match won 2-1 is 2 points.

Match lost 1-2 is 1 point.

Match lost 0-2 is 0 points.

Walkover (0-21, 0-31) is 0 points.
